

Bill Collector In A Box™ Account Donation Agreement

This Agreement for Collection Services ("Agreement") is made and entered into effective _____, 20____ ("Execution Date"), by and between Marauder Corporation d/b/a "Bill Collector In A Box" ("BCIAB") and _____ ("Contributor") (collectively, the "Parties").

Contributor hereby permanently and irrevocably donates net proceeds from the collection of the attached permanently assigned debts to the charity selected below. I understand that the remittance of any funds collected less the servicing charges of fifty-percent of every dollar collected by Marauder Corporation to cover the costs and expenses of the collection action against the debtors of the donated accounts will be forwarded to the selected charity on or before the end of the month following the collection activity. Receipts for donations will be sent directly to Contributor by the recipient charity.

Contributor shall defend, hold harmless and indemnify BCIAB from any claims of Debtors or other third parties, including federal and state governmental agencies, arising by reason of Contributor's provision of incorrect or false information, including but not limited to incorrect or false information regarding Debtor's name, Account debt, fees, interest, residence, employment, family, references or any other information regarding Debtor or other third party that may proximately lead to or cause BCIAB, its Agents or employees to engage in illegal or ethically improper behavior in rendering the Collection Services.

BCIAB shall defend, hold harmless and indemnify Contributor from any claims of Debtors or other third parties, including actions arising from federal and state governmental agencies, arising by reason of Collection Services rendered by BCIAB and its Agents to Contributor.

For each Account donated BCIAB shall promptly acknowledge in writing the following information: Debtor name, amount of debt and date entered into the collection process. Upon receipt thereof, Contributor shall immediately notify BCIAB of any error, omission or discrepancy in Debtor's Account information.

Contributor warrants that it has not assigned or sold to a third party any Accounts donated in the care of BCIAB. Contributor further warrants that it has full title to all donated Accounts and the Accounts are not subject to any claim, lien, encumbrance, trust, conditional sales contracts or other rights or interests of any person or entity, and that all Accounts donated are valid legal debts owed to Contributor by Debtor. Contributor warrants that there is no suit, action, legal, administrative or other proceeding, governmental investigation, or to the best of Contributor's knowledge, pending, threatened against or affecting the Accounts or the underlying Debt.

Contributor agrees to forward all payments made directly to Contributor on donated accounts to the address below. Contributor agrees to notify BCIAB all phone contacts, settlement offers, letters, bankruptcy notices, threats, disputes, counterclaims, or any other communication of whatever kind or by whatever means ("Communications") received from or on behalf of Debtor, his/her attorney or representative.

BCIAB is granted full settlement authority to effectively negotiate settlements and expedite funds to selected charity. BCIAB will perform collection action on donated accounts as long as fiscally possible. Typically 5-7 years from date of occurrence.

The undersigned Parties warrant that they are duly authorized to enter into this Agreement on behalf of each of the respective Parties hereto.

This Agreement shall be construed in accordance with and governed by the laws of the State of California. This Agreement shall be construed as being executed in Riverside County, California.

BCIAB will remit net collected proceeds (after BCIAB servicing charges) from the donated accounts to the following charity (Select One):
